## PRESIDENT



**Michael Kintscher** 

Michael Kintscher is a PhD student at Arizona State University studying collaboration. Michael began organizing as a queer person serving as a National Officer in the Boy Scouts of America, where they organized internal resistance to a ban on queer members. Michael is entering their 10th year at ASU. Through their time on the Rainbow Coalition Executive board, and as a student organization adviser, Michael partnered with faculty and staff to plan events and campaigns outreaching to marginalized communities. Michael spent the past three years serving in Graduate Student Government as a key leader internally organizing to push for shared governance. Michael also spent the past two years serving on the UCWAZ Finance, Legal Support, and Bylaws Committees, and is currently serving as Local President. Michael worked for seven years in the public sector and strongly advocates for higher education. Michael's policy work and persuasive writing caught the attention of the CWA National Vice President of Public Healthcare and Education Workers and served as the basis for the national CWA conversation connecting protest crackdowns to the labor movement following the mass arrests and gross violation of civil rights in the university responses to pro-Palestine encampments earlier this year. In a second term as Local President, Michael would further strengthen the committee structures to better engage members, and work with the Executive and Steering Committees to develop a proactive action plan to secure a permanent seat at the decision-making table for the workers that make higher education run.

## President



**Dave Wells** 

UCWAZ needs structural changes at universities and ABOR to enhance worker power. Dave retired in December 2023 after 25 years of service as a teaching professor at Arizona State University, 10 years serving actively in the university senate, and three times as president of the college assembly for the College of Integrative Sciences and Arts, including in his last semester shepherding an inclusive process in a divisive environment to pass new bylaws. Dave joined the union in June 2022 after, with no warning, five colleagues' contracts were not renewed He helped lead a college union working group to resist an increasingly toxic environment that created a survey that identified widespread dissatisfaction. The Provost dismissed the findings, and the situation continues to deteriorate. Dave plans to build a more active union both internally and externally that backs students, staff and faculty and expands our rights. He has a track record with his current work, research director for the Grand Canyon Institute. He facilitated a media campaign in 2018 for charter school accountability that led to results and became a key point in the legislative and governor races for both parties. During COVID, he organized a coalition that successfully increased state unemployment insurance benefits for the first time in 17 years. He's also been cited repeatedly as a critic of UAGC since its inception. Through interactions with governance units, publicizing research, pressure campaigns, media outreach and personal outreach to every member, Dave seeks to guide the union to a more influential position.

# VICE PRESIDENT



Marcos Esparza

Marcos Esparza is a PhD student in Optical Sciences and Engineering at the University of Arizona. Within our union, he is currently active in the organizing and student committees. With the organizing committee, he has helped with recruiting efforts by making welcome calls to new members and participating in building walkthroughs/canvassing. With the student committee, he has helped with various campaigns and has worked with other students to organize events such as this year's U of A DisOrientation and a Chop From the Top teach-in. He has attended multiple ABOR meetings (at the U of A and NAU), participating in the public comment portion where he has spoken in support of union issues such as bundling graduate student fees into tuition and the Chop From the Top Campaign. Within U of A shared governance, he is an at-large representative for the Graduate and Professional Student Council where he serves on the research policy committee. As vice president of our local, he plans on working with our union members and staff to focus on our recruitment efforts to increase our union power and sustain our current and future campaigns with the goal of achieving a collective bargaining agreement. ## TREASURER



Miranda Lopez

After graduating in 2018 from the University of Arizona, Miranda worked for the statewide Democratic Coordinated Campaign for two consecutive cycles, first as a Field Organizer and later as a Regional Organizing Director. She then worked for the Pima County Democratic Party (PCDP) in 2021 as their Executive Director. During her time as ED, she gained hands-on experience with submitting campaign finance reports, and created a new system to track the county's spending and fundraising goals. In the spring of 2023, she started working for the Arizona Students' Association (ASA) as their Southern Regional Organizing Director; ASA works to advocate for students in the AZ state legislature, to develop student leaders on college campuses, and to mobilize these students to take action against harmful legislation. This fall semester, Miranda and her students registered almost 600 students to vote in this year's general election. She is also a full-time student now pursuing her Masters in Public Administration. As an active member of UCW's organizing committee, student caucus, and new UA caucus, Miranda has helped UCW organize rallies and speakers at ABOR events on the UA campus. She wants to bring her skills and experiences to the position of UCW Treasurer by ensuring that all accounting and financial reports are kept up to date and made transparent to the general membership. Additionally, she believes her leadership on the Executive and Steering Committees will provide an essential perspective from someone who is both a UA graduate student and deeply connected to the organizing community in Southern Arizona.
